Participatory Learning: Teaching involves cooperative group-based learning, where departments like Community Medicine engage students in health surveys and diagnostics within communities, encouraging reflective problem-solving skills.

Problem-Solving Methodologies: PBL is widely used, providing case scenarios that prompt students to diagnose and devise management plans, fostering analytical and creative thinking.

Self-Directed Learning: Guided by university guidelines, students receive relevant topics and resources to independently explore advances in their field. They participate in research projects and group seminars, enhancing their knowledge and presentation skills. Patient-Centric and Evidence-Based Learning: Real-life case studies encourage students to apply evidence-based strategies and hone communication skills. These are assessed through Objective Structured Practical Examinations (OSPE).

2.3.5 - The teaching learning process of the institution nurtures creativity, analytical skills and innovation among students

The Medical Education Unit (MEU), in collaboration with the NMCregional centre, organizes workshops to train faculty in innovative teaching methodologies, including the Curriculum Implementation Support Programme for CBME.

Departments of Physiology, Biochemistry, Community Medicine, and Pharmacology conduct Problem-Based Learning (PBL) sessions where students analyze clinical scenarios in groups under faculty guidance. Community-Based Education led by the Community Medicine Department involves students in health surveys, awareness programs, and medical camps, enhancing primary healthcare skills. Team-Based Learning and flipped classroom methods are also implemented, with preparatory materials, readiness tests, and interactive discussions to foster collaborative learning. Creative activities like drawing, poetry, and rangoli competitions are organized by Anatomy and Physiology departments. Model-making competitions are conducted by Physiology and Biochemistry departments, rewarding the best projects.

The Psychiatry department engages students in small mental health projects. Students actively participate in conferences, workshops, and intercollegiate competitions, winning several accolades. The 'Sherlock Holmes Club' by the Forensic Medicine Department encourages debates on ethical and legal issues.

The Pharmacology Department features a Computer-Assisted Learning lab with ExPharm software, promoting interactive learning. It also implements antibiotic and pharmacovigilance worksheets and hosts medal exams to identify talented students. Educational events like guest lectures, career guidance sessions, and motivational talks are regularly conducted to enrich student learning.

2.5 - Evaluation Process and Reforms

2.5.1 - The Institution adheres to the academic calendar for the conduct of Continuous Internal Evaluation and ensures that it is robust and transparent

The institution follows a well-organized academic calendar developed prior to the start of the academic year in consultation with all departments. The Academic Council or Curriculum Committee's recommendations are incorporated to ensure alignment. The academic calendar includes schedules for theory classes, practical sessions, internal assessments, and model exams, following the university calendar. Plans for additional remedial sessions outside regular hours are also included.

Continuous Internal Evaluation is conducted according to university guidelines, allowing each department flexibility in determining examination formats and frequency, with decisions made through faculty discussions. At the start of each course, students are informed about the evaluation process, course objectives, attendance requirements, grading, and schedule for internal and model exams. The calendar's schedule for classroom instruction and clinical postings is displayed on department notice boards.

Internal assessments and model exams are held with strict supervision, employing CCTV and mobile jammers to prevent malpractice. Absentees with valid reasons are permitted to reschedule. Various formative assessment methods, including group discussions, seminars, and projects, are incorporated. Multiple faculty members handle answer sheet evaluations to ensure unbiased grading. Results are posted on notice boards within a week, and any grievances are addressed before final marks are consolidated and submitted to the Vice Principal's office.

The Controller of Examinations (COE) position, established in January 2019, oversees end-of-semester exams and assists in internal assessments. Exams are organized similarly to university standards, with departmental heads setting confidential question

Velammal Medical College Hospital & Research Institute (VMCH & RI) has a dedicated Examination Section responsible for the organized conduct of internal assessments, term-end exams, and resolving examination-related issues. This section ensures adherence to university guidelines and communicates clear instructions for fair examination procedures. A defined protocol is also in place to address grievances related to exams.

Grievances Regarding University Examinations: Pre-examination Grievances and Redressal Procedure For late submission of university exam applications, students can approach the college examination section, which coordinates with the university. Applications are accepted with a fine of Rs. 1,500 if within three days post-deadline or Rs. 3,000 if within six days. If hall tickets are delayed, the examination section escalates this to the university's controller for prompt resolution, allowing tickets to be accessed online. Errors like incorrect register numbers, damaged barcodes, or defective answer sheets are corrected immediately by the chief superintendent issuing a new answer sheet.

Post-examination Grievances and Redressal Procedure The university handles re-evaluation for students scoring below 50% in theory, performing double evaluations automatically. Revaluation is not permitted, but students can request photocopies of their answer scripts after passing clinical/practical exams for self-review and improvement, without entitlement to additional marks.

Grievances Regarding Internal Examinations: An examination committee at the college manages internal exam-related concerns. The college follows university guidelines for internal exams, preparing and sharing timetables in advance. Exams are supervised by faculty, with departmental heads ensuring question paper accuracy. Valuation is conducted collectively by faculty, with feedback provided to students post-evaluation.

Summative assessments are conducted by Dr. M.G.R University, covering both theory and practical exams.

Affiliated University has bar coding system.Examination halls have jammers, CCTV surveillance to prevent malpractice. Candidates are mandated to bring Hall tickets and to be seated half-an-hour before examination. Electronic communication devices are strictly prohibited.

The Chief Superintendent is responsible to dispatch the following documents on the same day of examination through speed post.

Continuous Internal Assessment System

Formative assessment is done through Centralized Internal Assessment, presentations, seminars, and assignments, non-formal assessment on observation of individual student's participation in group work, classroom learning and initiatives. Internal assessment exams are announced in advance. Test papers are evaluated by faculty in rotation and results announced within seven to ten days of examination. Doubts or grievances are discussed in feedback sessions and addressed by the respective faculty who evaluated the papers and will be informed to HOD. Periodical OSPE/OSCE with feedback, MCQ test and class tests at the end of each completed portions, viva voce sessions are conducted.

The Curriculum Committee of the institute plays a crucial role in planning, implementing, and evaluating the teaching programs. It regularly reviews the existing syllabus and encourages reforms, particularly the development of an integrated curriculum, and the adoption of innovative teaching, learning, and evaluation methodologies. A key initiative in the institute is the implementation of integrated teaching-learning approaches, incorporating horizontal, vertical, and transdisciplinary integration. This approach involves collaboration between preclinical and clinical departments to deliver relevant topics more effectively. For instance, the Attitude, Ethics, and Communication (AET COM) module, along with Competency-Based Medical Education (CBME), was introduced for the 2019-20 MBBS batch. Following the Graduate Medical Education Regulations (GMER) 2019, the MBBS curriculum aligns related topics across different subjects within the same phase, eliminating redundancy and ensuring interconnectedness. Vertical integration emphasizes the application of basic science concepts in clinical practice. An

Alignment and Integration Team (AIT) consisting of faculty from various departments ensures that the integrated topics are effectively delivered. The AIT designs learning and assessment sessions for these integrated topics, ensuring cooperative and collaborative teaching methods. Student learning outcomes are regularly analyzed, and slow and advanced learners are identified for tailored interventions. Students are also encouraged to engage in community outreach, skill development workshops, quizzes, and symposia. Assessment methods such as OSPE/OSCE, role plays, and workshops are utilized to align teaching with learning outcomes, ensuring a competency-based educational approach.

VMCH&RI is deeply committed to institutional social responsibility, involving students and staff in various community outreach initiatives related to education, environmental health, socio-economic development, and affordable healthcare. Through these activities, VMCH&RI aims to cultivate socially responsible medical professionals.

The Department of Community Medicine leads health talks promoting awareness of diet, exercise, lifestyle modifications, immunization, sanitation, and personal hygiene. Surveys, including village health, diet, and vector assessments, are conducted in adopted villages to monitor health needs and raise awareness about communicable and non-communicable diseases. Students also gain hands-on exposure through community field visits and partnerships with NGOs supporting vulnerable groups such as individuals with mental illness and leprosy.

Students are stationed in urban and rural centers during their internships, allowing them to observe and deliver primary healthcare.

Key services include:

- Free healthcare through rural and urban centers
- Village adoptions, where families in 12 villages receive health services and support
- Health camps led by the General Medicine Department
- Eye camps, in collaboration with the District Blindness Control Society, screening patients and providing free treatment
- Free outpatient and inpatient treatment, including free medication and subsidized investigations
- Relief work during natural disasters, such as Cyclone Michaung, where VMCH&RI conducted medical camps and distributed essential supplies

These outreach programs offer invaluable service to the community, allowing students to apply medical knowledge while developing a sense of social responsibility that will guide them as future healthcare providers.

The Civil and Engineering Maintenance Departments are headed by a qualified senior engineer/Maintenance Manager, responsible for regular maintenance of civil works such as furniture repairs, masonry and plaster works, painting, carpentry, and plumbing maintenance of rest rooms, approach roads, and ensuring cleanliness. Engineers and Technicians maintain electrical supply, electric appliances, and gadgets, distribution of lines, cables, panels, transformers, and diesel generators.

Laboratory and Equipment Maintenance is done by Biomedical Engineers, covered under AMCs for optimum working condition. Stock registers and log books are maintained for proper record keeping, with verification done at the end of every year. Laboratory technicians maintain laboratory records supervised by HODs. Firstly the instruction is given to all to use the water judiciously to minimize the generation of liquid waste. The liquid waste from the toilets, waste water from hostel and quarters are transferred to sewage treatment plant (STP) through sewerage system. In STP all the contaminants are removed and the effluent is been treated, the treated water is used for gardening and maintaining the green environment around the campus.

Bio-medical waste management:

All the necessary precautions are taken to ensure that bio-

medical waste generated in the hospital are handled with due care without creating any harm to health and environment. The waste are collected in appropriate colour coded bags and stored at safe, ventilated and secured location. All the waste are collected by a separate agencies , where they are treated and disposed as per biomedical management rule 2016.

It involves students rotating through stations, each designed to test specific clinical competencies such as history-taking, physical examination, procedural skills, communication, and clinical reasoning. Stations are standardized with checklists to ensure fairness and consistency.

Workplace-Based Assessments (WPBA), such as Directly Observed Procedural Skills (DOPS) and Mini Clinical Evaluation Exercises (Mini-CEX), evaluate students in real or simulated clinical environments. These assessments emphasize formative feedback and direct observation.

Logbooks and Portfolios track students' longitudinal progress in clinical competencies. They document procedures performed, case histories taken, and reflective learning, ensuring comprehensive skill acquisition.

The use of simulation-based assessments offers a safe environment

for students to practice and demonstrate skills without compromising patient safety.

Lastly, periodic theory and practical examinations assess integrated understanding and application of clinical knowledge. Combined, these methods align with CBME principles by focusing on outcome-based education and producing competent, patient-centered physicians.

- Legal issues this subtopic highlights the various legal issues involved in organ transplantation.
- It highlights on the various legal documents needed, what is

the eligibility to be a donor and what are the legal conditions fulfilling the living donor, dead donor and who can be a recipient and what are the relationship limits to be a donor etc,.

- It also emphasis on the various unethical practices and unethical acts related to organ transplantation.
- Ethical issues This session enlightens the various ethical issues involved in the organ transplantation.
- The core of this subtopic is to how and when a doctor can pronounce a person as brain dead, so that he will be eligible as a donor.
- What are the various criteria which were followed in the past and what are the criteria that are followed presently to pronounce brain stem death.

Describe the functioning of the Immunization Clinic in the Institution as per the quality specifications stated in WHO guidelines and the steps taken to provide students with information on its relevance and operational features within 100-200 words.

The collaboration between the Departments of Paediatrics and Community Medicine at Velammal Medical College Hospital and Research Institute (VMCH&RI) is essential for improving vaccination rates among children in Madurai. The Velammal Immunisation Clinic has been in operation since the establishment of the college, offering varoius vaccines and organizing regular immunization sessions. This ensures that both inborn and outborn infants receive timely vaccinations in accordance with national schedules. The clinic functions as both a vaccination center and a practical training facility for around 150 undergraduate and 2 postgraduate students each year. These students acquire practical experience in vaccination techniques and adverse effect monitoring, which is essential for their development. In addition to this, immunization is given to the children in Rural and Urban Health Training Centre on fixed day fixed schedule basis. The clinic is equipped with essential facilities, including temperature-controlled storage for vaccines and a strong quality control system to ensure adherence to WHO guidelines. Regular evaluations of children's nutritional status and medical histories are performed to guarantee thorough care. The clinic's performance undergoes regular assessment by a specialized committee, guaranteeing exceptional standards of service delivery. The integrated approach of education, practical training, and quality assurance at the immunization clinic plays a crucial role in enhancing vaccination rates and health outcomes for children in the region.
